Positive Resolution Policy for Children

Developed by: Staff and School Board

Note: All references to 'Staff members' include Administration Staff, Support Teachers, Teachers and Temporary Relieving Teachers.

Underlying Assumptions, Philosophy and Rationale:

We at Mary MacKillop Memorial School believe that:

- safety, a basic human right, is a pre-requisite for our school to be able to carry out our mission to educate
- children have the right to be emotionally and physically safe at all times
- the dignity of the human person is fundamental to Catholic teaching. Catholic schools operate in a wider community context where legal requirements exist and where they have an obligation to children and young people.

Purpose/Aims:

Through the application of this policy, we at Mary MacKillop Memorial School aim to:

- base our policy on the Gospel values of freedom and justice for all and an underlying belief in the dignity and uniqueness of each person
- ensure the safety and wellbeing of the child is considered paramount in every situation.

Guidelines:

In support of this policy:

The Principal will:

- ensure that all children have an understanding of this policy including the flow chart that
 outlines the steps they need to take to achieve a positive resolution to their problem
- encourage children to participate in the review of this policy through student voice
- encourage children to learn strategies in problem solving

- encourage staff members to listen carefully to children and to counsel them appropriately in self managing their problems or offering more direct assistance as needed
- use strategies from LBI Resilient Impact eg What-What-How framework and Growth Action Plans
- ensure all staff members are trained in Resilient Impact
- communicate Resilient Impact strategies to parents/carers to use at home with children/young people
- encourage students to utilise W-W-H and Resilient Impact strategies to learn to solve problems.

All Staff members will:

- ensure they are fully aware of this policy and teach the children the steps they need to take to achieve a positive resolution to their problem
- be trained in Resilient Impact What-What-How and Growth Action Plans
- utilise LBI strategies to help children
- help children to understand the difference between those problems that need help from an adult and those that can be solved without adult intervention
- help children to understand the importance of reporting something that is serious, may cause harm or is illegal
- work closely with parents or carers when necessary to support children in achieving a
 positive resolution to their problem.

Children and Young People will:

- follow the steps required to achieve a positive resolution to their problem
- seek support from their parents, class teacher or suitable adult to support them to achieve a solution to their problem

Parents/Carers will:

- ensure they are fully aware of this policy and support their child(ren) when seeking a
 positive resolution to their problems
- work closely with the school when necessary to support their child(ren)
- use LBI language to encourage problem solving strategies that mimic school
- help children to understand the importance of reporting something that is serious, may cause harm or is illegal

Implementation:

- All staff members will have access to this policy.
- All staff members will be trained in Resilient Impact through Life Buoyancy Institute.
- All parents/carers or volunteers who have direct supervision of children will be made aware of this policy.
- All parents/caregivers and community members will be informed of this policy via the newsletter and the school's website
- The flowchart will be published in each classroom so that children are aware of the steps they need to take to achieve a positive resolution to their problems.
- The names of all relevant Government Agencies will be checked and updated on the review date of this policy.
